

OFFICIAL RULES

The Challenge: Record and submit a Video of your in-house worship ministries performing either of the two noted songs by Regi McClurkin for a chance to win valuable prizes for your church.

Choose either "Rejoice" or "We Praise You" from the latest release "Music In The Air" by Min. Regi McClurkin. Then record your church music ministry performing the chosen song during an actual live worship service. Performance must include the entities of either choir and/or praise team; along with group of liturgical dancers, step teams or mime ministry. All top 3 winners will be judged and chosen based solely on their originality, creativity and for using full elements as being an all-inclusive corporate worship experience.

Restrictions and Terms:

- This challenge is open to any and/or all Churches or Worship Centers of any denomination, race or nationality; without exception, worldwide.
- All entries must submit a \$25.00 non-refundable entry fee.
- All entries must be postmarked by official deadline **November 30**, **2019** and winners will be announced and notified on **December 27**, **2019**; also with results being posted on social media.

Prizes

First Place Winner (Valued at \$3,500):

- Min. Regi McClurkin will perform a free full concert appearance at your church.
- Entities will be featured on the official music video of song being released worldwide.
- Church and all entities will be listed and noted on official "BlackGospel Promo Ad."
- \$500 cash donation will be made to church.

Second Place Winner (Valued at \$2,250):

- Min. Regi McClurkin will perform a free mini-concert appearance at your church.
- Church and all entities will be listed and noted on official "BlackGospel Promo Ad."
- \$250 cash donation will be made to church.

Third Place Winner (Valued at \$1,125):

- Min. Regi McClurkin will perform during a morning worship service at your church.
- Church and entities will be listed and noted on official "BlackGospel Promo Ad."
- \$125 cash donation will be made to church.



Official Challenge Rules and Regulations:

- All submitted entries must be fully completed and postmarked by listed deadline.
- All submitted entries must be recorded on site at the domicile church location.
- A Dropbox link will be provided for all entries, no shaky videos will be accepted.
- All submitted entry videos must be recorded and formatted in 4K or UHD with a minimum bitrate of 8bits (higher preferred). Video <u>must not</u> be edited in any way and only one good take of the performance will be accepted.
- All Praise Teams must have at least 6 people, all Choirs and/or Ensembles must have at least 20 people and all dance routines must have at least 6 people.
- All submitted videos must have singers and dancers simultaneously performing throughout the entire duration of their chosen song.
- Each and every person appearing in submitted video must sign a release waiver.
- A noted representative of all entries must be listed/named on submission form.
- A noted Representative of all entries must sign and complete a release waiver.
- All dates for appearance by Min. McClurkin are scheduled solely by OPC, Inc.
- All dates for appearance by Min. McClurkin at the winners named church must be booked, contracted and secured within one year of the announcement date.
- All expenses for the appearances being at winners named church, including all airline travel, ground transportation, hotels, etc.; are full responsibility of winners.
- All expenses to regionally promote appearance of Min. McClurkin at the winners named church is solely the responsibility of the winners.
- All winners fully understand the appearance of Min. McClurkin does not include his own singers and/or band; but will be done with winner church music staff.
- All winners fully understand the standard honorarium fees for the appearance of Min. McClurkin are waived, however a generous love offering can be rendered.
- Challenge participants fully understands no submitted entries will be returned.
- Challenge participants are fully responsible for all related cost to submit entry.
- The "Church Challenge" may and will be ended without advanced notification or consequence if the minimal of 50 participating entries are not submitted.
